

AMENDMENT TO CONSENT ORDER

WHEREAS the New Jersey Division of Consumer Affairs, Office of Consumer Protection (“Division”), and Furniture For Less (collectively, the “Parties”) are parties to a Consent Order filed with the Division on December 29, 2009 (the “Consent Order”); and

WHEREAS the Parties mutually agree to amend Subsection 4.3 of the Consent Order (“Amendment”).


IT IS on this 4th day of February, 2010, **ORDERED AND AGREED** as follows:

1. Effectiveness- This Amendment shall be effective on the date it is filed with the Division. Except as specified herein, this Amendment is not intended to supercede, negate or otherwise alter any provisions of the Consent Order except as expressly set forth herein. Capitalized terms herein retain their meanings as defined in the Consent Order, except as expressly set forth herein.
2. Modification of Payment Schedule- The Parties agree to the full Settlement Payment of Two Thousand Seven Hundred Fifty and 00/100 Dollars (\$2,750.00). Subsection 4.3 of the Consent Order shall be amended as follows:
 - 4.3 Respondent shall make the Settlement Payment in twenty-five (25) installments as follows:
 - a. One Hundred and 00/100 Dollars (\$100.00) shall be paid on or before the Effective Date; and
 - b. The remaining Two Thousand Six Hundred Fifty and 00/100 Dollars (\$2,650.00) shall be paid in twenty-four (24) equal monthly installments of One Hundred and 00/100 Dollars (\$100.00), with each installment due on the first day of each month, beginning February 1, 2010, with the final installment due on January 1, 2012.
3. Representations and Warranties- The Parties Represent and warrant that their signatories to this Amendment have authority to act for and bind the respective Parties. This

Amendment shall be binding upon the Parties and their successors in interest. In no event shall assignment of any right, power or authority under this Amendment avoid compliance with this Amendment.
